COURSE DESCRIPTION

This coursentroduces you to the principles of statistical reasoning and inference. To this end, the ultimate goals of the course are for you to thoroughly understand the following concepts: sampling distributions, hypothesis testing, and confidence intervals across multipliengs.

Organized into fourteen modules de courses divided into four parts The first part of the course provides an overview of how data is properly collected and how to explore data using visual and numerical methods. The second part is an introdicion to probability theory, discrete and continuous probability distributions and mathematical expectation. The third part introduces sampling distributions, confidence intervals and hypothesis testing. Finally, the last section applies statistications to propulation means, to proportions and to simple regressions. This foundational course is essential to your success in the study of economics. CU economiesed 000 courses require knowledge of basic statistical reasoning and understanding. Further, our econometric courses build directly off this course.
